This agreement is between the Vancouver Island Uilleann Pipers' Club (HICUPS) and the borrower. 1. Contact Information HICUPS contact: Borrower: 1. Full name 2. Street address 3. City, postal code 4. HICUPS will lend the pipes (described in section 10) to the borrower on the terms and conditions of this agreement. 2. The pipes shall be loaned from _____ until _____, the loan period. 3. Collection and Delivery of the Pipes 1. The borrower shall arrange a mutually convenient time to return the pipes in person to HICUPS at the end of the loan period.

4. Payment

1. The pipes are to be loaned free of charge.

5. Title and Risk

- 1. Title and all rights to the pipes shall at all times remain with HICUPS. The borrower acknowledges that s/he has no right, title or property in the pipes.
- 2. Risk of any loss or damage to the pipes will become the responsibility of the borrower upon them leaving HICUPS' possession and shall not revert back to HICUPS until the pipes are returned to HICUPS.

6. HICUPS' Obligations

HICUPS agrees to:

- 1. Check the pipes to ensure they are playing properly at the start of the loan period.
- 2. Provide the borrower with an introductory lesson covering the assembly of the pipes, use of the bag and bellows, and basic fingering.
- 3. Be available to provide further support at the monthly meetings, and at other times by means of email or telephone.

7. Borrower's Obligations

The borrower agrees that during the loan period s/he will:

- 1. Keep the pipes in his/her possession and control, and ensure that they are secure against loss, damage and theft.
- 2. Keep the pipes in moderate indoor conditions, away from extremes of heat, cold, humidity and moisture.
- 3. Keep the pipes in good working order.
- 4. Not undertake any modifications to the pipes, including non-reversible modifications to the reed(s).
- 5. Notify HICUPS of any change of address or other primary contact information.

8. HICUPS Recommendations

In order to maximise the potential for progress and minimise the frustration often associated with learning the uilleann pipes in isolation, HICUPS *strongly recommends* that:

- 1. The borrower should attend, whenever possible, the HICUPS monthly meetings.
- 2. The borrower should arrange, if possible, for lessons from an experienced piper.

9. In the event of the pipes being lost or damaged

1. The borrower agrees to pay the replacement cost as indicated in section 10 below.
